#### Illinois Civil War Muster Rolls

Francis M. Cooper age 16 a farmer living in Pittsfield, Pike County, Illinois enlisted in Co H, 137 Illinois US Infantry. He was listed as being born in Highland County, Ohio and was 5' 2" with light hair and gray eyes.

He enlisted on 16 May 1864 at Quincy, Illinois for a period of 100 days and mustered in 6 June 1864. He mustered out 24 September 1864 in Springfield, Illinois.
