Ared Benjamin Gibbs was born in Missouri to David S. Gibbs and Ophelia M. Hinman. His siblings were Rufus, Winfield Scott, Moro, Charlotte (Ogden), Laura A., and Oliver Gibbs. After the death of his father, his mother remarried to George Buchanan.

Arron B. Gibbs was married to Ella in the 1880 Census, with a son Marr (Maro Elmer Gibbs). In his Veterans Home Papers in 1903 he stated that he was widowed, and divorced

Two of his brothers, Winfield Scott Gibbs and Moro Gibbs also served in the Civil War. Maro with Co C, 15 Kansas Cavalry and Scot with Co D, 137th Indiana Infantry Regiment.

Ared B. Gibbs enlisted on 6 August 1864 in St. Joseph, Missouri, mustered in 17 September 1864 as a Private, and mustered out on 30 June 1865 in Benton Barracks, Missouri. Ared Gibbs was admitted into the National Home for Volunteer Soldiers at Sawtelle, California on 9 November 1903, and discharged on 29 April 1904, and died on 3 May 1904.

Ared Gibbs was a Member of the Sedgwick Post Number 17, of the GAR.

In 1881, the Supreme Court of Kansas made a ruling in a case between Ophelia Buchanan vs Maro Gibbs over the probate of George Buchanan. The ruling showed that Maro Gibbs was the son of Ophelia Hinman by a former husband.
