Darwin Kerr's brother-in-law Charles M Vertrees fought for the Union with Co E, 17<sup>th</sup> Illinois US Infantry

Mehittable Kerr's paternal 3<sup>rd</sup> great grandfather, Jacob Van Meter, fought in the Revolutionary War for Virginia. He served under George Rogers Clark at the Kaskaskia Campaigns in 1778. He also commanded a company in Clark's expedition against Indian renegades who were under the command of Simon Girty in 1782.

Mehittable Kerr's great grandfather, Loudon Carol of Virginia, was a drummer boy during the Revolutionary War.

Mehittable Kerr's 2<sup>nd</sup> great grandfather, John Vertreese of Monongalia County, Virginia, fought under Colonel Thomas Gaddis in the Indian Expeditions of 1778.

Mehittable Kerr's 3<sup>rd</sup> great grandfather, Samuel Haycroft, fought for Virginia
