Newell Kinsman, 36, a native Orange County, Vermont residing in Wyanet, Bureau County, Illinois enlisted as a Private in Co H, 51<sup>st</sup> Illinois US Infantry. A carpenter by trade he enlisted on 25 October 1861 at Wyanet, Bureau County, Illinois. He mustered in 28 December 1861 at Chicago, Cook County, Illinois for a period of 3 years. He mustered out 28 February 1865 as a Sergeant at expiration of his term.
