John Charles Ord - Biographical Data

John Charles Ord was the son of Alexander Ord and Ann Colliston. He enlisted on 17 June 1862 at the age of 20. He mustered in 9 July 1862 to Company E, 9th Vermont Infantry as a Private, and mustered out 13 June 1865.

He saw service in Winchester, Harper's Ferry, Virginia and North Carolina. In 1865 he was attached to the Sharpshooter Brigade, and saw service in the Battle of Petersburg. He was in the Grand Review at the close of the war in Richmond.

He helped organize the Baxter Post, G.A.R., at Newport, Vermont.

John C. Ord is considered the father of Seal Beach, Orange County, California, where he served as a Mayor, Judge and Postmaster.

He was at the surrender of Lee

He was the last surviving member of his regiment

Moses W. White, the father of his first wife, also served in Company E, 9th Vermont Infantry.
