Illinois Civil War Descriptive Rolls

Emil C Partsch enlisted under the name of John Berg as a Private with Co G, 82nd Illinois US Infantry. He was 18, a farmer and living in Lebanon, St Clair County, Illinois. He enlisted 11 August 1862 at Belleville, Illinois for a period of 3 years. He deserted 3 November 1863 and was apprehended 4 April 1864. He mustered out 9 June 1865 at Washington, DC

Emil W Partsch born in La Grange, Fayette County, Texas age 18 enlisted 21 October 1863 in St Louis, Missouri with the consent of his father, C. Partsch. He enlisted for a period of 3 years with Co G, 2nd Missouri Light Artillery.
