Illinois Civil War Detail Report

John Pyle age 21 and residing in Carmi, White County, Illinois enlisted as a Private in Co C, 40th Illinois Infantry at Liberty, Illinois 3 August 1861 for a period of 3 years. He was a farmer born in Jackson County, Ohio and married at the time of enlistement. He mustered in 10 August 1861 at Camp Butler.

John's son, Frank Leslie Pyle, became a Lt Colonel in the US Army. He served from 5 June 1900 to 20 October 1925.

John's father, Cortez, fought with the Missouri State Militia during the Civil War.

John's great grandfather, John Pyle III, was a private in the Revolutionary War.
