Civil War Detail Report

Anderson Williams age 22 born in Ohio and residing in Pinckneyville, Perry County, Illinois enlisted as a Private in Co G, 81st Illinois US Infantry for a period of three years. He enlisted on 7 August 1862 in Perry County, Illinois and mustered in 26 August 1862 at Camp Anna, Illinois. He mustered out 5 August 1865 at Vicksburg, Mississippi.

Lafayette Campbell, Margaret Blake's first husband, also fought with Co G, 81st US Infantry Illinois. Lafayette enlisted at Jackson County, Illinois on the same date as Anderson Williams. Lafayette died 24 February 1864 at Memphis, Tennessee
